

TERMS AND CONDITIONS OF THE “FREE RENTAL WEEK” DRAW

1. Organizing Entity and Purpose of this Draw

This promotional activity will be organized by TALLERES MARTÍN SL (hereinafter ESPACAR), holder of Tax ID No. B29076270, with registered address at CTRA CADIZ, NUM. 163, 29680 ESTEPONA (MÁLAGA), and aims to allow rent-a-car customers to participate in the “FREE RENTAL WEEK” draw governed by the following terms and conditions, with participation taking place for promotional purposes.

These promotional terms and conditions will be available at www.espacar.com and are mandatory for participants in order to enjoy the prize if selected as the winner(s).

2. Contest Users and Participation Mechanics

The contest is open to individuals over 25 years of age and residents within European territory who make an online reservation between May 15 and June 15, 2026, for the rental of a vehicle for 7 or more consecutive days, for the period from June 20 to August 31, 2026, provided that the user has not cancelled said reservation before June 15.

Such users will automatically participate in the contest upon making the reservation, without the need to register or provide additional information other than that already collected to formalize the rental reservation itself.

Under no circumstances will participation by persons under 25 years of age or those legally incapacitated for any reason be permitted.

Employees of TALLERES MARTÍN SL, as well as their first-degree relatives by blood or affinity, are excluded from participation.

Persons who do not meet these conditions may not participate in the draw and will be disqualified.

3. Contest Dates

This contest will be active from 05/15/2026 to 06/15/2026, both dates inclusive, until 11:59 p.m. on the final day (Mainland Spain time).

The draw will take place on Wednesday, June 17, 2026, through the draw option on the platform <https://echaloasuerte.com>, selecting 1 winner and 2 alternates.

4. Prize

The prize consists of one free week of vehicle rental with Espacar Rent a Car, to be enjoyed until August 31, 2026. There will be only one winner and one draw.

Since the draw is held among users who have already made a minimum 7-day reservation, the prize will consist of the refund (or non-charge) of the amount corresponding to the first 7 days of the reservation, applying during said period the same rental conditions specified in the reservation prior to the draw (model, location, etc.).

If the winner has a reservation longer than 7 days, the refund (or non-charge) will still apply only to the first 7 days, without prejudice to the payment corresponding to the remaining days, provided that the first 7 days fall within the period from June 20 to August 31, 2026.

The winner will be selected according to the following procedure:

1. ESPACAR will conduct a random draw resulting in 1 winner and 2 alternates.

2. If the winner is disqualified for failing to meet the requirements established in these terms and conditions, they will not be entitled to the prize, which will then be awarded to the next selected alternate, and so on up to the third alternate if necessary.
3. ESPACAR shall not be obliged to inform participants whose prize entitlement has been withdrawn, only the final winner who meets the required conditions.
4. The winner will be informed by e-mail at the address included in our database and/or by telephone whenever possible.
5. If the winner does not provide the information or documentation requested by ESPACAR, or does not meet the requirements of these terms and conditions to be a participant and winner, even if they have been announced as the winner or selected in the draw, the prize will be assigned to the first alternate who meets all the conditions of these promotional terms and conditions.
6. The prize may not be exchanged for any other gift or redeemed for cash.

5. Prize Communication

ESPACAR will publish the promotional terms and conditions of this draw on its website www.espacar.com. Likewise, the name of the winner and the dates for enjoying the prize will be published on said website and on the company's social media channels, once it has been confirmed that the winner meets the participation requirements and accepts the prize.

If, for reasons beyond the company's control, it is impossible to contact the winner within 48 hours from the draw date, or if within that same period the winner expressly and verifiably declines the prize, ESPACAR will contact the participant selected as the first alternate, and so on successively.

ESPACAR may request from winners any information or documentation necessary to verify compliance with the participation conditions and therefore eligibility as winner; failure to provide such information will result in disqualification.

This information may be requested by e-mail to the address provided by the participant, and the winner will have two (2) calendar days from the sending of the e-mail to provide it. Winners who do not provide the requested information or documentation, or who after verification fail to comply with any participation or winner requirements, will be disqualified and the prize will be assigned to the next selected alternate. In such case, ESPACAR shall not be obliged to contact participants who have lost their entitlement to the prize.

ESPACAR may request and publish photographs of the winner and their companions, both before and during enjoyment of the prize, for publication on ESPACAR's social media channels. Acceptance of this last condition is essential in order to enjoy the prize, since the draw is conducted for promotional purposes and to publicize ESPACAR's activities.

6. Company Liability

ESPACAR shall not be liable for any damages or losses that may occur while the winner enjoys the prize, nor for cases of force majeure that may prevent the winner from enjoying it.

ESPACAR shall be exempt from any liability in the event of errors in the data provided by participants that prevent their identification and therefore their participation.

ESPACAR reserves the right to remove from the draw, for justified cause, any user who cheats, alters, or disrupts the proper functioning and normal and regulated course of the draw and its conditions.

7. Processing of Personal Data

By participating in this draw and accepting the prize, the winner authorizes TALLERES MARTÍN SL to use personal data, including image rights, for the purpose of communicating and

disseminating the winner's name and the prize obtained through its communication channels, website, social media, and similar means, without any right to additional compensation.

By accepting these terms and conditions, the participant freely consents to the processing of their data for the purposes about which they have been informed.

8. Applicable Law

For all matters not specified in these legal terms and conditions, the promotion shall be governed by the Spanish regulations in force at the relevant time.

In the event of litigation, the Courts and Tribunals of Estepona (Málaga) shall have jurisdiction, without prejudice to any other jurisdiction that may apply under applicable regulations.

9. Acceptance of these Contest Terms and Conditions

Simple participation implies acceptance of these promotional terms and conditions. Therefore, any statement rejecting all or part of them will imply the exclusion of the participant and, consequently, ESPACAR shall be released from fulfilling any obligation contracted with said participant regarding this promotion.

10. Claims

The written claim must include the participant's full name, exact address, and a detailed description of the reasons for the claim.

ESPACAR will review and resolve claims within 7 days from the date of receipt of the claim. The organizer's decision regarding the claim shall be final and binding.
